Subject: Letter from the Mediterranean Alliance for Wetlands – urgent action needed to protect the wetlands of the Erimitis peninsula

Your Excellency, Mr. Prime Minister,

We are writing as a group of international environmental organizations and members of the Mediterranean Alliance for Wetlands to urge you to prevent the destruction of the wetlands of the Erimitis peninsula.

In October 2020, you received a previous letter from the Mediterranean Alliance for Wetlands, signed by 16 organizations working across the Mediterranean region, where we expressed our serious concern about the proposed construction of a tourist resort in the Erimitis peninsula (the "Kassiopi Project").

In that letter we highlighted how the Erimitis wetlands are not only a site of natural beauty, which attracts locals and tourists alike, but also represent a significant natural asset for Greece, providing ecological services such as erosion protection and water quality regulation. The Erimitis peninsula is one of the few remaining unspoiled parts of north-east Corfu and contains a great diversity of habitats, including three important coastal wetlands in Corfu (Vromolimni, Akoli Pond and Savoura), which are protected by the Greek Presidential Decree 229/AAP/2012. Erimitis' three wetlands are an important 'stopover point' for migratory birds crossing the north of Greece, a number of which are classified as threatened and officially protected under the Birds Directive of the European Union. Additionally, numerous species protected by the EU Habitats Directive also depend on the existence of these wetlands, such as the European pond terrapin and the dice snake (see Appendix).

As outlined in that letter, the proposed Kassiopi Project could have serious implications for the habitats and species of two of Erimitis' important coastal wetlands, Vromolimni and Akoli. The threats associated with the project include increased noise pollution, water pollution, light pollution, alteration of the catchment area and water regime, loss of vegetation and ecosystem fragmentation.

Not having received a response to our previous letter, we are writing to you again as it has subsequently come to our attention that preliminary construction works associated with the Kassiopi Project have now begun, including the deforestation and clearing of the plot. We were shocked to learn that heavy machinery passed on Friday February 19th through the boundaries of the protected wetland Vromolimni, constructing a road on the seaside shore of the wetland despite being outlawed according to the ministerial decree for small wetlands (Code Y22KER030, ΦEK AAΠ 229/19.06.2012).

We therefore urge you to reconsider the development of this project and implement appropriate conservation measures in order to comply with the obligations to which Greece has committed itself at the national and international level, including:

- Permission of only minor activities that would not alter the ecological properties of the wetlands within this area, such as hiking and running through the existing paths, and nature observation and research.
- The designation of this area as a protected area in line with Directives 92/43/EEC and 2009/147/EC, and national law 1650/1986 (as amended), instead of promoting unsustainable and environmentally-damaging development projects such as the Kassiopi Project.
- The adoption of conservation measures for the protection of the specific habitats and species in line with the Bonn and Bern Conventions and the EU nature Directives.
- The effective implementation of the presidential decree 229/AAP/2012 on small island wetlands and appropriate measures for the protection of these wetlands.

As the global tourism industry reopens following the devastation of the Covid-19 pandemic, the eyes of the world will certainly be on Greece. We consider that you and your government have a unique opportunity to demonstrate to the world your leadership in addressing the environmental crisis and promoting sustainable development, which considers local needs and wishes and adheres to international and EU law.

Instead of allowing damaging development, we ask that Erimitis be used as a flagship for ecologically compatible tourism and the conservation of nature and natural beauty across the Greek islands.

We the undersigned organizations remain at your disposal to provide any further information required and to contribute our expertise to support the protection and preservation of the valuable coastal wetlands of the Erimitis peninsula.
